



## Artist Guidelines

### What is Empowering HeArts?

Empowering HeArts is an annual celebration of women who have changed lives and shaped their communities. It bridges the worlds of social action and artistic expression in an annual arts competition.

Honorees are nominated by the community and selected by the Single Mothers Outreach (SMO) Board of Directors and Empowering HeArts Planning Committee.

The Empowering Hearts Gala presents the creative works of Santa Clarita Valley artists who create unique and inspiring art forms inspired by these real life stories. Art is juried and two prizes are awarded as follows:

- Dottie Award - awarded to the artist who creates the most compelling visual story.
- People's Choice Award - awarded by the gala attendees from votes taken at the event

It is SMO's hope that through sharing these powerful stories in word and art, these extraordinary women will impact and inspire others to rise above their own circumstances.

Empowering HeArts is SMO's signature fundraising event. All proceeds from the event are used to support programs which empower single parents to effectively care for their families.

### The Theme: Resilience

Artists are asked to create artwork of their honorees. Inventive interpretation of the theme as it applies to each honoree is strongly encouraged of the artists, as are imagination and personal artistic style.



In keeping with the supportive spirit of Single Mothers Outreach, and to the greatest degree possible within the artists' own disciplines, artists are asked to assure that the Honorees are identifiable to people who know them when viewing the finished art.

It is critical that the artists work closely with their Honorees. Each Honoree will be given the art made by the artist they're matched with, and must be comfortable with how they are portrayed.

### **Benefits of Participation**

- Appropriate mention of authorship in all uses by SMO
- Complimentary admission for the artist and a guest to the Empowering Hearts Gala event

### **Expected Use**

SMO reserves the right to exhibit, reproduce entries and retain the proceeds of any sales as unrestricted income. Other expected uses include, but are not to be limited to: pamphlets, event programs, photo books, calendars, note cards, newsletters and display upon the SMO website.

### **Gala Event**

The Gala showcases the honorees and her artist and the artwork is shown to the public for the first time. Local dignitaries, family, friends and the greater SCV community are invited to view the art and read the stories of each of the honorees and watch the awarding of the two prizes handed out that evening.

- (Jaycees), members of local women's clubs (Soroptimist International, Zonta International) and SCV Media. Along with other community members.
- Approximate number of guests: 225
- Dress: Elegant cocktail attire
- Cost: \$65.00 (complimentary for artist and a plus one)
- Refreshments: elegant culinary arts hors d'oeuvres and wine/soft drinks

### **Honoree and Artist Pairings**

The Empowering HeArts Planning Committee will choose the artist's subject for the project by a computerized *random* selection process. Under no circumstances will artists or honorees be permitted to choose their partners.

### **Art Medium**

The art medium is photography, collage, sculpture or painting.

### **Entry Rules**

- There is no entry fee.
- Artists must produce art depicting the assigned story.
- All resulting art will be given to the honoree and will not be returned to the artist.
- A description of the artwork must be listed on the contest entry form, which accompanies the entries.

#### ***\*Rules for Photographers***

1. Reasonable digital adjustments are permitted.
2. A .jpg file of at least 300 dpi of the pieces must be submitted. SMO is not required to use any piece produced by the photographer. No watermarks or other such distortions of the image are permitted.
3. Signed SMO Model Releases of participants will be provided to the photographers for their records upon assignment of their honoree.

#### ***\*Rules for Sculptors***

1. Sculptures must be no wider than 2 ft. and no taller than 4ft.



### ***\*Rules for Painters***

1. Minimum 18" on the short side
2. Max 36" on the long side

### **Display**

- Photography/Collage - mounted on 1/4 inch foam core.
- Painting/Watercolor- framed or presented in a way that it can be hung from a standard art wall
- Sculpture (or other non-hangable art) - free standing or be able to be set atop a standard art pedestal.

### **Financial Responsibility**

Participating artists provide and pay for all art mounting, framing, and customized art display aids. A \$100 stipend to help cover costs will be given upon request.

### **Art Deadlines**

- Artist's sample portfolio and application must be submitted to SMO for approval by September 18<sup>th</sup>, 2017 (please submit 5).
- The announcement of the chosen artists will be on September 21<sup>st</sup>, 2017.
- After announcing the artist and honoree pairings, artists must bring in a description of the planned artwork on October 2<sup>nd</sup>, 2017 (written description must contain at least 50 words.)
- Final artwork must be submitted to SMO by January 8<sup>th</sup>, 2018.

### **Judging**

Judges will be tasked with jurying art submissions based on the following criteria:

- Effectively captures competition theme (15 pts)
- Story telling (15 pts)
- Impact (15 pts)
- Style: (10 pts)
- Composition (10 pts)



- Creativity (5 pts)
- Lighting/Shading/Depth (10 pts)
- Color Harmony (10 pts)
- Technical Excellence/Print Quality (5 pts)
- Technique (5 pts)

Judges' decisions are final and in their sole and absolute discretion.
